New Business

SECRETARY'S REPORT

The board members reviewed the minutes from the July 9, 2024 meeting. Audrey Koester motioned to approve the minutes, which were seconded by Barbara Butler. The motion was carried.

TREASURER REPORT

Tom Poole, the Treasurer, reported an error in the reports from January to June 2024 before reviewing the July Treasurer report. When attempting to transfer \$2900 from the Broadview Mint Share Account (Old Scutter Account) into a 6-month Certificate of Deposit, it was discovered that there was only \$2070.90 in the account instead of the expected amount. As a result of this error, the CD amount was adjusted to \$2000. This error was addressed in the Treasurer Report submitted on August 13, 2024.

The board members carefully reviewed and analyzed the Treasurer's Report for July 2024, taking into consideration the corrected error. Barbara Dzembo made a motion to accept the report with corrections, and Christopher Chien seconded the motion. The motion was carried.

Old Business

A thank you note was sent from the Schoharie Promotional Association for the Hill Country Cloggers' performance at their Lily Festival.

President Beaudoin confirmed that the tarp had been taken off the trailer and that there were no tears in the new tarp bought last year.
