

ELECTRIC USAGE

1. NO extra electrical lighting (flood, or pole lights) allowed on sites or hung, strung or attached to trees.
2. You may **NOT** trench or run cords in/on the ground. Lights may ONLY be attached to your trailer/awning.
3. ALL lights and Air conditioning must be turned off when Seasonal is not here for an extended time. (Longer than a day)
4. All trailers designed for 50 amp service MUST remember they will only receive 30 amps.

PETS

1. **ALL** pets on the property **MUST** have their rabies and distemper shots. A copy of the vaccination must be on file at the office.
 2. Pets MUST have their tags displayed at all times.
 3. Pets MUST be kept under control, **on leash** (MAXIMUM of a six foot long) at all times. Noisy, aggressive or quarrelsome pets **WILL NOT BE TOLERATED AT ALL AND ASKED TO LEAVE IMMEDIATELY.**
 4. Dogs may not be left in trailers or pen to bark or whine...they are a part of your family so take them with you.
 5. Dogs may never be left outside unattended.
- ALL** campers **MUST** clean up after their pets. Please remember our field is used for activities. DO NOT ALLOW PETS TO RUN AND MESS FREELY. Clean up after them in ALL places on the campground, NO MATTER HOW LARGE OR SMALL YOUR DOG IS. If your child refuses to clean the mess when walking the pet they shouldn't be walking it. **DO NOT WALK YOUR DOG ON CAMPSITE OTHER THAN YOUR OWN.**
6. Pets are NOT allowed in the pool area, playground or in any building.

POOL

BY ORDER OF THE NEW YORK STATE DEPARTMENT OF HEALTH: NEVER SWIM ALONE. THERE IS NO SUBSTITUTE FOR ADEQUATE SUPERVISION. A minimum of two (2) adults, 18 years of age or older must be present when swimming. One person must remain on the deck at all times. A Parent or Guardian must accompany children under the age of 18. IN AN EMERGENCY, NOTIFY THE FACILITY OPERATOR AND CONTACT HELP AS SOON AS POSSIBLE. CALL 911 AT Office Telephone. Only swim in designated area. No one under the influence of drugs/alcohol is allowed in pool. No fires allowed in the pool area. No glass allowed in pool area. Only use facilities during posted hours. NO FOOD OF ANY KIND in the pool area. Water in an unbreakable container IS allowed, all other beverages are NOT. No smoking in the pool area. THE POOL IS SHALLOW **NO JUMPING OR DIVING! No running in pool area.**

FIRE SAFETY REGULATIONS

Every camper should be equipped with a working smoke and carbon monoxide detector and at least one working portable fire extinguisher in accordance with the New York State Fire Code. Although Schroon River Campsites does not inspect each individual camper for the safety equipment, our goal is your safety as well as the safety of the guests that are around you. We are working in conjunction with the Warrensburg Volunteer Fire Company and the Warren County Office for Fire Prevention and Building Codes to assure your safety. Therefore, we are asking for your cooperation in making sure you have a safe and enjoyable stay.

1. A working smoke detector should be place in a location where the alarm will alert someone that is sleeping to an incident and to allow for early evacuation of the camper. This is a basic safety device that has been built into every camper for years. Please take the time to test yours and make sure the vital, life-saving device is working properly.
2. Almost all campers have propane-fired equipment (stove, furnace, hot water heater) and all equipment that burns fossil fuel creates carbon monoxide. This odorless and colorless gas kills hundreds of people each year. In 2008 New York State adopted "Amanda Law" that requires a working carbon monoxide detector within 15' of any sleeping area that has a carbon monoxide producing source within the building.
3. A portable fire extinguisher is required in your camper and again, we ask for your cooperation in making sure the unit is not only charged and ready for use but also placed in an area for quick and easy access to the unit should something go wrong while you are visiting us.

Failure to Pay

Failure to pay final payment for the 2021 camping season by May 14, 2021 will result in termination of your Seasonal status.

Failure to pay 2021 deposit by required date will result in termination of seasonal status.

Once "seasonal status" is terminated, all "property" that is still on Schroon River Campsites premises will be considered abandoned and will be removed from the site at owner's expense. The site will be completely cleaned, and all items will be disposed of.

Trailer removal..... \$600.00
Site cleaning.....To be Assessed
Trailer storage.....\$50.00 per day

We will hold the trailer and items left on site for thirty days, after which the trailer and items will be considered trash and will be disposed of. If you wish to reclaim the trailer and items within the thirty days, all fees must be paid before they will be released.
