Installation of a Regency Hi2450 wood stove insert connected to an insulated stainless steel liner system : CHIMNEY HEROES PROPOSES TO COMPLETE THE FOLLOWING:

Bring system up to NFPA 211 fire and safety standards by installing a Regency Hampton Hi2450 wood burning insert with an insulated stainless steel chimney liner

Proper equipment used for protection for property, persons

Prepare firebox and damper area for appliance installation

Prepare flue before liner installation

Installation of a UL listed stainless-steel \*insulated\* liner

Installation of appliance and connect liner

Installation of faceplate

Installation of chimney cap, top plate

Clean area and remove chimney construction debris

Show customer before and after pictures

Walk through operation of appliance and owner's manual with customer

\*\*WARRANTY INFO: To maintain lifetime manufacturer warranty on liner, system needs to be annually inspected by a certified chimney sweep. This warranty does not include labor. Appliance has a separate warranty details in owner's manual\*\*

2) Material escalation clause: due to the global supply issues, material has the ability to change. This is out of Chimney Heroes control.

3) If you would like to customize this proposal a change order is required.

4) Hidden damage clause: Any work that is required to be done due to any hidden damage or unforeseen circumstances that could not have been reasonably ascertained at the time of inspection may be subject to a change order.

5) Owner shall provide a 110-exterior electrical outlet (or access inside the house for extension cord) and access to an exterior water faucet. If these utilities are not available at time of appointment and causes us to cancel or reschedule a \$300 fee for the lost day of wages will be charged.

WE HEREBY PROPOSE to furnish labor and materials complete in accordance with this proposal specifications for the approximate amount stated below. This proposal is confidential and may not be shared with other contractors. In an instance where a chimney is improperly constructed, we are not responsible for prior construction defects. Customer agrees to pay as outlined above. Past due amounts greater than 30 days will be subject to 10% per month interest charge. If escrow is involved, the homeowner will be responsible to see that we receive payment as outlined above. All agreements contingent upon weather, accidents, or delays beyond our control. Please be aware that we always try to keep our schedule, but weather or problems encountered with a prior job may occasionally delay the start of your job. Owners to carry fire, and homeowners insurance. Our workers are covered by workers compensation and liability insurance. We reserve the right to place a lien on the property and report to the credit bureaus if payment is not made in full.

- This repair will ensure the insert will have one continuous passageway for the exhaust to vent out of the chimney.

- Remove the damper housing and enough firebrick to make room for the liner to enter the firebox.
- Install an **INSULATED** stainless steel M-Flex liner kit and all related components. Price includes labor and materials. Comes with a manufacturer's lifetime warranty.
